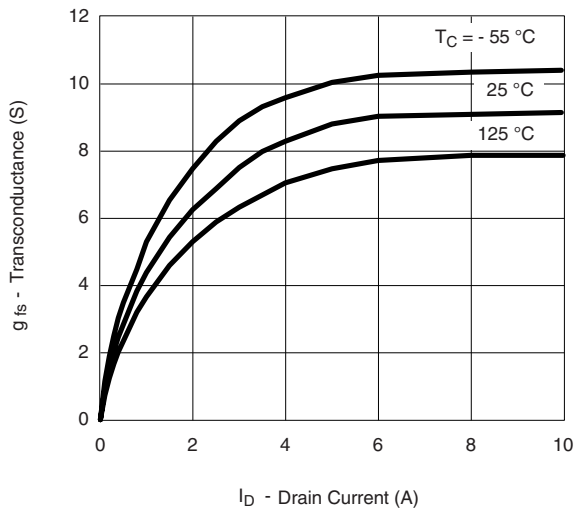
TYPICAL CHARACTERISTICS 25 °C unless noted



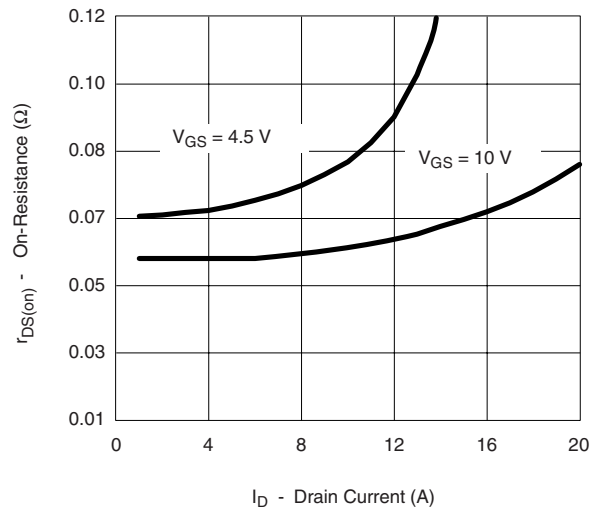

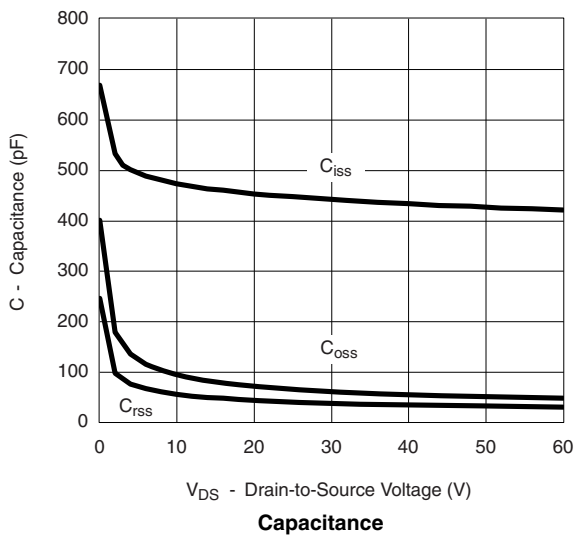
Transfer Characteristics



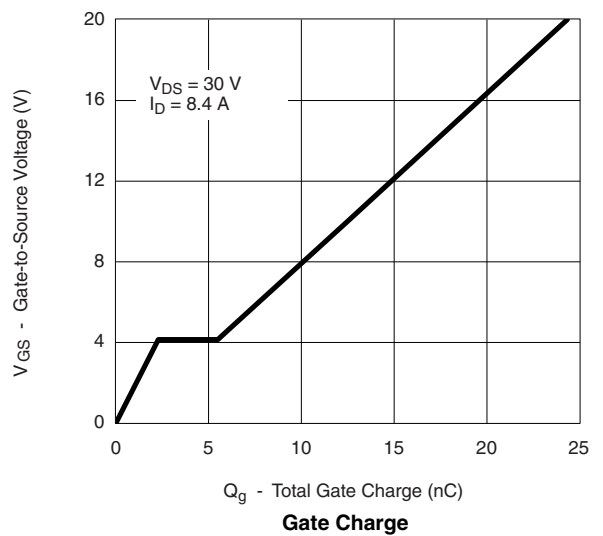
Transconductance



On-Resistance vs. Drain Current

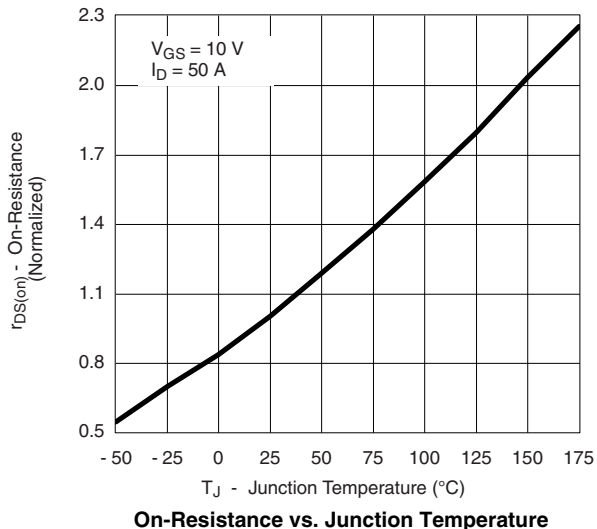


Capacitance

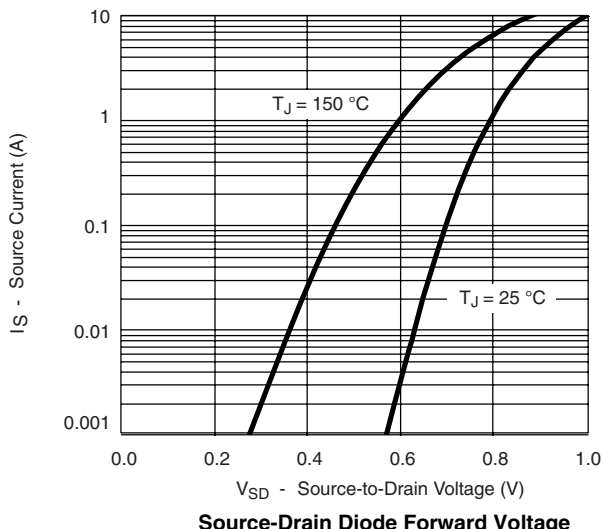


Gate Charge

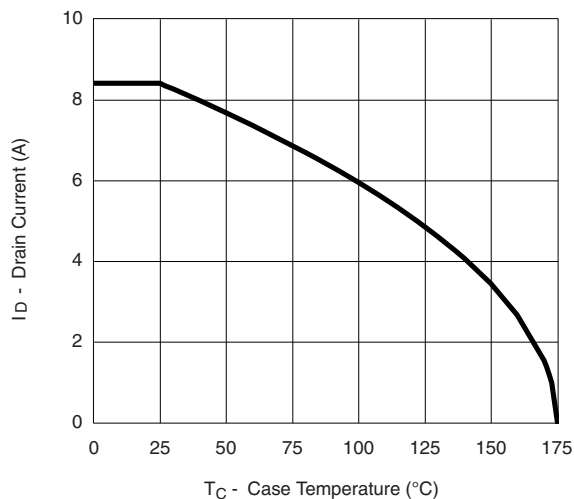


On-Resistance vs. Junction Temperature

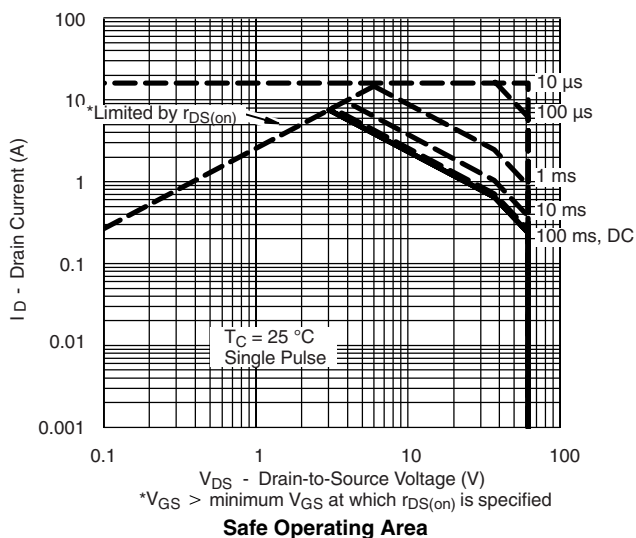


Source-Drain Diode Forward Voltage

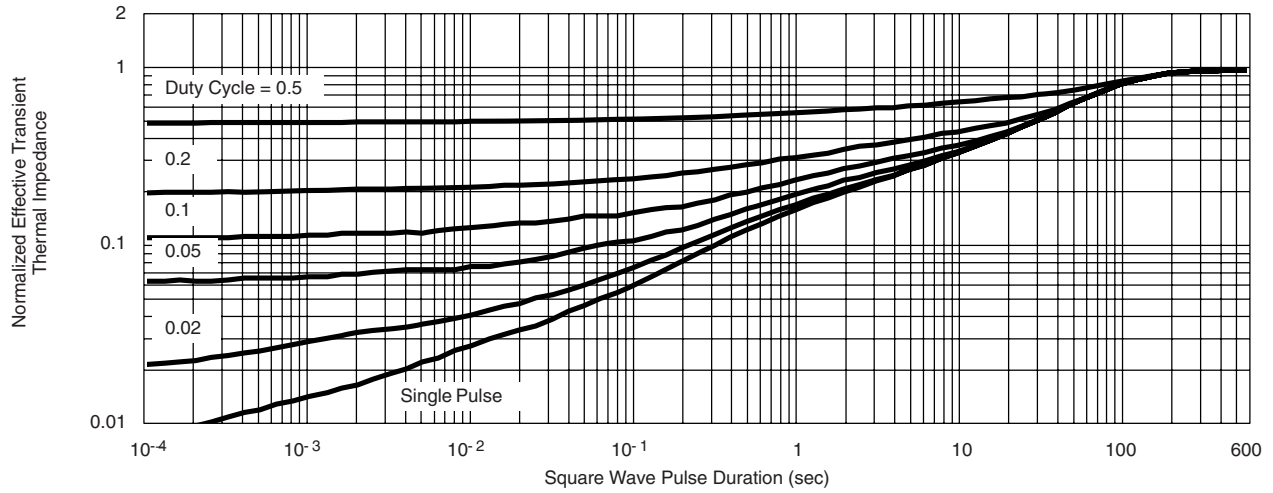


Drain Current vs. Case Temperature

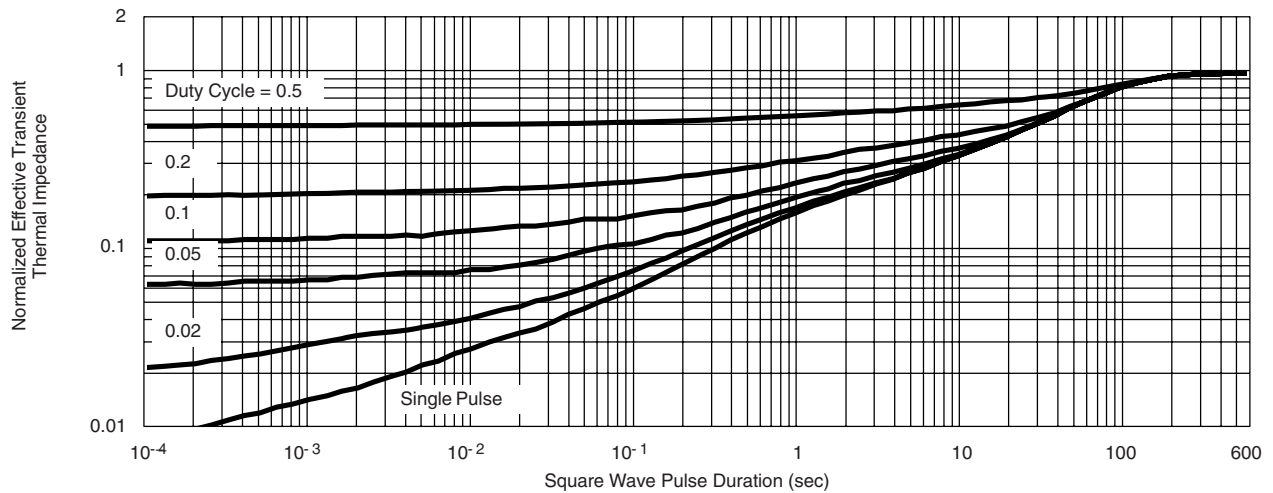


Safe Operating Area

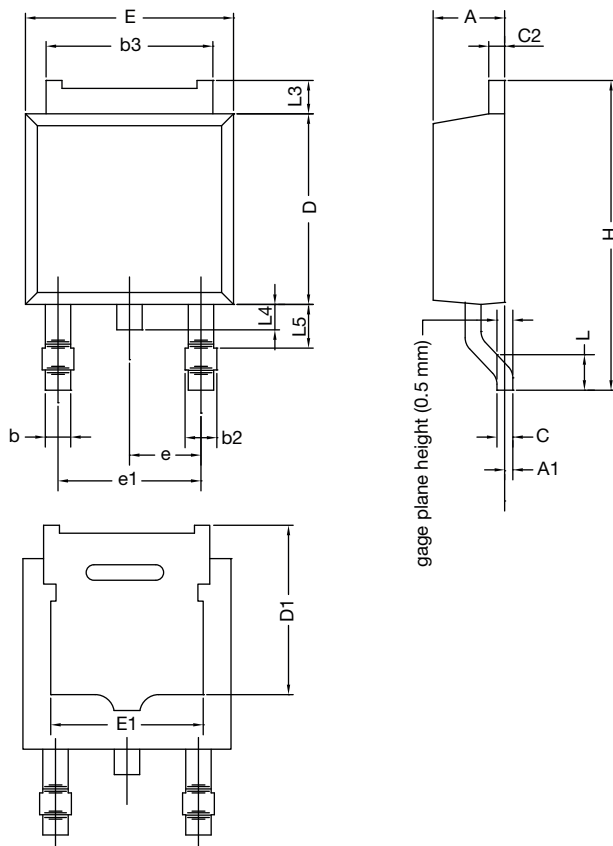


Normalized Thermal Transient Impedance, Junction-to-Ambient

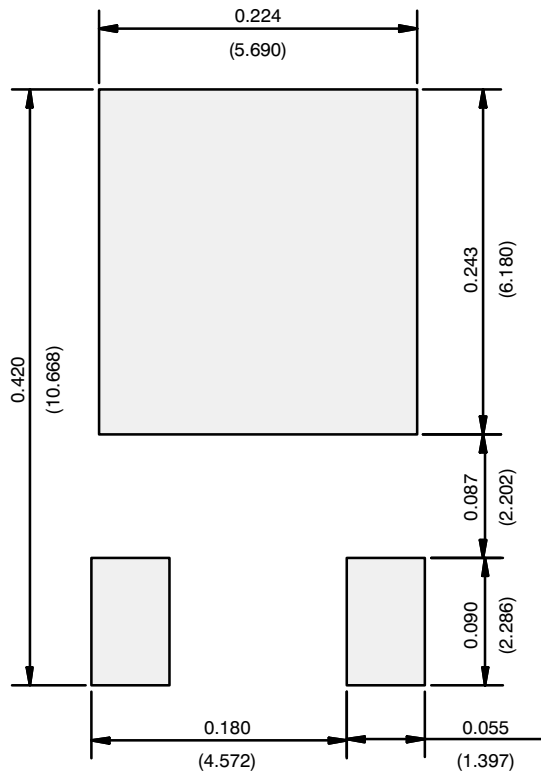
